Project of The Month: Atma Nirbhar – Ek Challenge' (ANEC)

'Atma Nirbhar – Ek Challenge' (ANEC) which means 'Self Reliance – A Challenge', is an economic rehabilitation and empowerment project for the differently abled individuals of the society. It was established near Rehabari, Guwahati, by Late Kaushik Das in 1996. He left behind a 22 year long successful career as an industry expert to branch into the role of a Good Samaritan attempting to develop a germ of an idea into a noble venture.

There are very few employment opportunities for the unskilled special needs persons in developing countries like India. 'Atma Nirbhar – Ek Challenge' shows that, given due consideration and facilities, the disabled can become productive and contributing members of society. The Vision of this organization is to create equal opportunities for the disabled and to contribute towards a greener world.

AFNA has been associated with ANEC almost since the days of its establishment. Thanks to the regular donations of a few generous individuals and families, we have been able to provide some essential contributions to the organization over the years. AFNA played a major role in difficult times of the organization by providing much needed financial and advisory support. The relationship between the two organizations extends to some wonderful initiatives like the unique "Spreading Sunshine" Project and the AKADAMICS college scholarship program.
